1. SITUATION/BACKGROUND

The purpose of this report is to provide narrative to the Month 2 position of NWJCC for the 2025-2026 financial year.

The financial position is reported against the 2025-2026 baselines following approval of the WHSSC and EASC Integrated Commissioning Plans by their respective Joint Committees of the 7 Health Boards in March 2025.

2. ASSESSMENT

The NWJCC financial position for 2025-2026 reported at Month 2 was an overspend to date of £1.7m, with a forecast overspend position of £0.4m against the ICP financial plan.
